- 1. Introduction Prospective board member Christa Shields: Christa Shields has expressed an interest to join the board. She is a Shorewood resident with a background in fund development. A. Finance Subcommittee (Director Simon)

The SRC has experienced challenges over the last several years in retaining staff members particularly those focused on Programs. One of the driving factors was these roles have been designated as part time, and there has been budget constraints that have not allowed this to be designated a full-time position. This has impacted the SRC's ability to fully reopen and provide the programming they desire.

In working with the SRC Board, the Elder Services Board, and the Village Attorney we drafted language to amend the Spending Policy to allow for Benjamin Funds to be used to fund the wage differential and benefits for a full-time equivalent employee.

We did not amend how we calculated the amount of annual funding available to the SRC, and any dollar amounts used to fund wages and benefits will be coming from the calculated annual allocation.

We also modified the Spending Policy to represent how the Benjamin Funds are invested and managed.

Follow-up Discussions: The SRC has asked about their ability to spend the Principal of the Benjamin Fund. This is not precluded within the Policy, but the SRC would need to seek approval from the Foundation Board for any funding beyond the annual allocation.

B. Communications/Marketing/Events (Marschka/Casey/Thachenkary)
Summer schedules have made it difficult for this group to meet but a July meeting has been

scheduled to discuss longer term plans, budget, and responsibilities. Listed below are updates, current areas of focus and plans for the upcoming months. We have also developed a grid that shows marketing channels, responsibilities, and structure for the board but will use this for planning when we meet. Updates include:

- Website: To reflect the "Marketing and Events" committee areas of focus, we have added a
 new "news" section to the SF website to provide a dedicated place to share announcements
 and upcoming news (grand marshals, scholarship recipients, new president, etc.).

- July 4th: Melissa Marschka established plans and volunteer walkers for the Shorewood Foundation Fourth of July Celebration however weather did not cooperate, and the parade was canceled, and fireworks rescheduled for July 9. We updated the information on social media and the website. In addition, we are working with President Lindvall to ensure the village is meeting the obligations of the sponsorship agreement.
- Shorewood Scholarship recipients: President Sadhna Morato-Lindvall represented the Foundation at the SHS awards night and awarded scholarships to this year's recipients, Selamawit "Sey" Caldart and Zeynab Javid. This was also featured on the website and social media.
